### CC791 – POLICE MATTERS

PC Gary Martin presented the following police report:

- Report of youths on the roof of Killearn Primary School.
- Male found in possession of cannabis in village and warned accordingly.
- Continuing parking issues at Finnich Toll.
- Male charged for theft of bank card from works premises in Killearn.
- Report of suspicious males in white Ford Transit in outskirts of the village. Police attended but confirmed everything in order.
- Lomond Mountain Rescue Team rescued walker who had fallen on west side of Dumgoyne and badly damaged her ankle.
- Loose metal manhole cover on road outside village caused damage to underside of local bus, ripping large holes in the floor. No persons were injured.
- Dog owners reminded about dangers of sheep worrying.

### **Other Planning Issues**

SC has asked for Screening Opinion in respect of Finnich Glen and Devil's Pulpit Killearn. Proposal is for Visitor's Facilities and a Car Park for 150 Cars and 5 Coaches. The proposal includes Picnic Areas, Bridges and Paths. SC has advised that an Environmental Impact Study will not be required, however consideration of Landscape, Traffic, Trees, Drainage and Access will be required with any formal Planning Application.

A closing date of 24 April has been set for offers for purchase of the Killearn Hotel by prospective developers.

Site at the bottom of Lampson Road has been purchased by Rural Stirling Housing Association with planning permission in principle granted for 13 Affordable Houses for rent. These will comprise 12 x two bed houses and 1 x four bed house.

SC planners are in correspondence with the persons responsible for erecting the traffic control barrier at the entrance to Headrigg Square, off Main Street.

In response to an email query, KCC advised the meeting that there is no planning permission for any further housing development on the Cow Field next to The Glen.

The meeting was informed that the former Depot at Dumgoyne Depot is surplus to SC's requirements. Winter grit is now stored in Callendar.

### **CC796 – ROADS AND GENERAL MAINTENANCE REPORT**

It was announced that SC Roads Dept have no current plans to mark out the no waiting/ no loading restriction on Balfron Road opposite Station Road.

On Station Road, the chicane has been moved to the opposite side of the road. A member of the public requested that road signage be put in place to warn drivers coming up Station Road of the new road layout. It was agreed Jim contact SC re same. It was also agreed KCC clarify the situation regarding the repair to the road edging in the same area of Station Road. (*Action JP/FR*)

A member of the public informed KCC of the manhole between The Old Mill and the War Memorial which requires attention. It was agreed Jim follow this up. (*Action JP*)

Further to the recent "Your Stirling You Decide" campaign, Jim informed the meeting of two proposals which have been submitted to SC – resurfacing of pavement at Allan Road and resurfacing of road at Napier Road/Station Road.

### **CC797 – COUNCILLOR'S REPORT**

In his report, Cllr Berrill highlighted the following:

- Proposed closure of Croftamie Nursery.
- Expansion of free nursery education from August 2020.
- Unsuccessful rural bus pilot on Balfron – Stirling route.
- Increase in notices issued with regard to antisocial behaviour, fly tipping and abandoned vehicles.
- Your Stirling You Decide campaign by SC for participatory budgeting.

Members of the public asked about the recent drastic pruning of the rhododendron bushes on Wellgreen. As this was organised by Killearn Trust, it was agreed Jim contact them for further information. *(Action JP)*

In an attempt to prevent anti-social behaviour, it was requested that lighting be installed in the pathway between Beech Drive and Graham Road. Jim to contact SC regarding plans for lighting. *(Action JP)*
