### **CC820 – MINUTES OF MEETING HELD ON 15 MAY 2019**

### **CC821 – POLICE MATTERS**

As the Police were unable to attend the meeting, Fiona presented the following report:

- On 28 May, report of local drunk male who appeared to be in wrong house.
- On 7 June, male found to be in possession of cannabis within a vehicle on Lampson Road.
- Report of noisy youths within grounds of Killearn Primary School on 15 June.
- Police traffic control at local 10K race.
- Reports of youths in vehicles causing annoyance within grounds of former Killearn Hospital. Police will continue to monitor this situation.
- Calls regarding parking at Finnich Glen.
- Road traffic accident on 10 June on A81 between Killearn and Blanefield.
- Local male arrested for theft by shoplifting from Co-op on 28 May.
- On 31 May, theft from Co-op reported. Two males from Glasgow area traced in Skye where they were doing the same thing.
- Two houses broken into in the Gartness area in early hours of 30 May. Jewellery and a vehicle stolen from one of the houses.
- In early hours of 1 June, attempted house break-in in Drumbeg Loan. Alarm system disturbed the perpetrators.
- On 1 June, attempted house break-in in Lampson Road but no access was gained to the house.
- Overnight on 20 June, tools stolen from uncompleted new build in Barclay Way.

## **CC824 PLANNING**

### **Proposed RSHA Houses on Lampson Road**

Jim introduced Donna Birrell, Chief Executive Officer of Rural Stirling Housing Association who spoke to the meeting about the proposed new development of 12 affordable houses at the bottom of Lampson Road.

Pending the results of a feasibility study on the suitability of the site, engineers and a design team will be appointed with a view to starting building work in the summer of 2020. Should the site be considered undeliverable, a buy back provision has been included in the legal agreement which will enable RSHA to recover the purchase price and return the site to the seller.

RSHA are keen to involve the local community in this development and would like to set up a local community panel to work with. Interested local residents should contact Donna at [donna@rsha.org.uk](mailto:donna@rsha.org.uk)

Donna explained that following the allocations for their properties at Blaressan, RSHA still has 33 applicants on their waiting list with connections to Killearn. The new homes will be allocated in accordance with RSHA Allocations Policy. See [www.rsha.org.uk](http://www.rsha.org.uk)

### **Proposed Development of Killearn Hospital Site**

Jim introduced Andrew Woodrow of Barton Willmore and Andrew Duncan and Michael Clements of CALA to the meeting who explained the 4-5 year programme to develop the site. A contract with the landowner was concluded in May with a proposal for 90 high quality CALA homes to be built on 21 acres. These will be a mixture of 3 bed terraced and semi-detached homes together with larger houses. The remainder of the site, approx 6 acres, will be developed for mixed use.

The whole site will be remediated and it is hoped house building will commence early in 2021.

Various questions were asked at the meeting on a variety of subjects from the need for starter homes and mixed use suggestions to transport and concern about future development between Lampson Road and the hospital site.

A public drop-in exhibition event will be held on 21 August in Killearn Village Hall from 2.00 – 8.00 pm. This will provide full information and members of the public are encouraged to attend, provide feedback on proposals and share their views.

## CC825 – ROADS AND GENERAL MAINTENANCE REPORT

Work has been completed on pavements on Branziert Road North and on A811.

It was requested that SC repair the manhole on Balfron Road pavement near the Pharmacy. (*Action JP*)

## CC826 – COUNCILLOR'S REPORT

Cllrs Davies and Lambie highlighted the following local issues:

- Full Stirling Council meeting to be held on 27 June.
- By 2033 every rural house will have access to fibre broadband.

- Patching on A811 to be surface dressed.
- Importance of putting forward suggestions for mixed use in hospital site.
- Concern about First Group selling off First Bus and impact on local transport.

Members of the public raised questions about the spread of giant hogweed in area and the need for access to resources for volunteers doing the work of former rangers. Cllr Davies agreed to raise these issues on behalf of KCC.

### **CC827 – TREASURER’S REPORT**

As Elizabeth was unable to attend the meeting, there was no treasurer’s report.

### **CC828 – QUESTION TIME**

The following questions were raised from members of the public:

- Urgent repair needed to hazardous dip in pavement on Main Street between the Well Green and Co-op.
- Weeds are breaking up the surface of the new pavement on Station Road. Attention needed before further damage ensues.
- Information was requested on petition by Co-op for pedestrian crossing on Main Street. (*Action JP*)

### **CC829 – YOUTH MATTERS**

Eva reported that all external exams have been completed and 6<sup>th</sup> year students have now left Balfron High. New prefects have been appointed and the school closes for the summer this week. She also highlighted that there is nowhere in the village for under 18 year olds to meet and that this might be contributing to the problems with local youths mentioned in the Police Report.

Fiona and Jim attended the SW Area Forum in May which focussed on the problem of speeding.
