Following the Inaugural Meeting chaired by Pam Campbell of SC Community Engagement Team, Jim welcomed the newly elected KCC members to the meeting. He explained that Heidi Bryce and Heather Wright would be co-opted onto the council in the future and that Eva Mailer would return as youth member.

It was proposed by Jim that Christine Bauwens be appointed Minutes Secretary and this was seconded by Elizabeth.

CC719 - MINUTES OF MEETING HELD ON 17 OCTOBER 2018

The minutes were accepted as a true record of the meeting.

CC720 - POLICE MATTERS

PC Gary Martin presented the police report, outlining the following:

- On 26 October the metal gates of the cemetery were stolen.
- House break-in at the Croy Cunningham Steadings on 12 November.
- Burnt out vehicle discovered on Cameron Muir on 17 November.
- Road checks continue to be carried out to catch and deter travelling criminals.
- Road traffic collision on A81 near Glengoyne Distillery on 15 November. One driver issued with a conditional offer of fixed penalty for careless driving.
- Ongoing issues relating to parking on A809 near Devil's Pulpit. This area is monitored on a daily basis.
- On 27 October, male found to be in possession of cannabis.
- Concern about antisocial behaviour after the village fireworks display. Youths
 were drinking and letting off fireworks to the annoyance of nearby residents. They
 also congregated in the primary school grounds, leaving broken glass bottles and
 cans in the playground.

CC721 - MATTERS ARISING

• CC709 - Finnich Glen

Jim reported on his recent visit to Finnich Glen to see the site firsthand and noted steps to stop further erosion and introduction of safety measures were necessary. It is hoped that the formal planning application for the proposed development will be submitted in February 2019.

- CC710 Roads and General Maintenance, Traffic Island Station Road
 Following discussion re the traffic island at the top of Station Road, it was agreed
 KCC write to SC outlining the following points expressed by the public:
 - Need for double yellow lines at Toll House
 - Possibility of moving island further down Station Road by 1 2 m
 - Equivalent of three parking spaces on each side of the road to be lost
 - o Bus stopping on Station Road could cause backing up of traffic
 - o Car parking problems within Killearn as a whole
 - Important to ensure space for two lanes at top of Station Road enabling traffic to turn left and right onto Balfron Road
 - Questioning if this project is good use of SC funds

CC722 - REPORT FROM KILLEARN BROADBAND GROUP

Doug spoke to the meeting, giving an update on the situation. The cabinet in Drumbeg Loan will be live by February 2019. The volunteer team creating the Stockiemuir Community Internet network are very close to going live. Blanefield/Strathblane are now totally connected to the fibre network. In Fintry work has started to install the cabinet opposite the exchange and the Drymen cabinet within Buchanan Castle estate can accept orders.

18/00774/FUL Formation of new dormer window to lower wing at The Moss, Drumbeg Road, Killearn, G63 9LJ KCC to comment on change to Grade C listed building.

18/00778/FUL Renewal of planning permission 15/00567/FUL for erection of two dwelling houses at Land and Buildings at former Hall, Main Street, Killearn No comment.
